Sales Conditions

These Sales Conditions ("Conditions") are a legally binding agreement between Assembly-Tek ("Seller") and the purchaser ("Buyer") regarding the sale of goods or services. By placing an order with the Seller, the Buyer agrees to be bound by these Conditions.

1. Order Acceptance:

- 1.1. All orders placed by the Buyer are subject to acceptance by the Seller.
- 1.2. The Seller reserves the right to refuse or cancel an order for any reason.
- 1.3. The Seller may require additional verification or information before accepting an order.
- 1.4. Once the order is accepted, the Seller will provide an order confirmation to the Buyer.

2. Pricing and Payment:

- 2.1. The prices of goods or services are stated in Australian dollars (AUD) and are exclusive of any applicable taxes, duties, or shipping charges unless otherwise specified.
- 2.2. Payment must be made in full before the Seller will ship or provide the goods or services.
- 2.3. The Seller accepts payment by credit card, bank transfer, or other methods as agreed upon between the parties.
- 2.4. If payment is not received within the specified time, the Seller may cancel the order.

3. Shipping and Delivery:

- 3.1. The Seller will make reasonable efforts to deliver the goods or services within the agreed-upon time frame.
- 3.2. Delivery times provided by the Seller are estimates and are not guaranteed.
- 3.3. The risk of loss or damage to the goods passes to the Buyer upon delivery.

3.4. The Buyer is responsible for providing accurate shipping information. Any additional costs incurred due to incorrect or incomplete information will be the responsibility of the Buyer.

4. Returns and Refunds:

4.1. The Seller's return and refund policy will apply to any returns or refunds.

4.2. The Buyer must notify the Seller within a reasonable time if they wish to return or request a refund.

4.3. Goods must be returned in their original condition and packaging, unless they are deemed faulty or defective.

4.4. The Seller may deduct any applicable restocking or handling fees from the refund amount.

5. Warranty and Liability:

5.1. The Seller provides a warranty for goods or services as specified in the warranty terms provided with the product.

5.2. The Seller's liability is limited to the cost of the goods or services purchased.

5.3. The Seller is not liable for any indirect, consequential, or incidental damages arising out of the use or inability to use the goods or services.

6. Governing Law and Jurisdiction:

6.1. These Conditions shall be governed by and construed in accordance with the laws of Australia.

6.2. Any disputes arising out of or in connection with these Conditions shall be subject to the exclusive jurisdiction of the courts of Australia.

7. Entire Agreement:

7.1. These Conditions constitute the entire agreement between the Seller and the Buyer and supersede any prior agreements or understandings, whether written or oral, relating to the subject matter.
